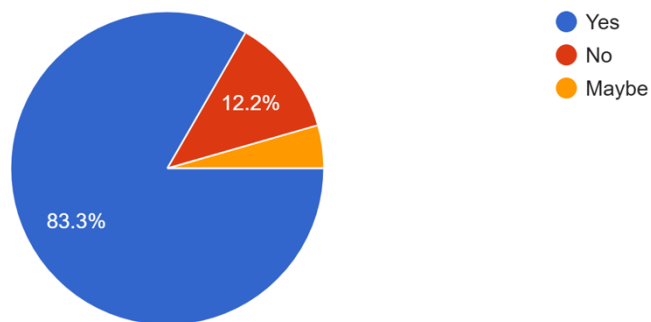

Results from survey - to 9th February 2025.

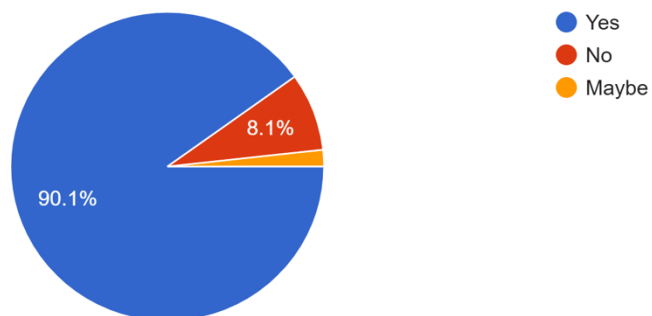
1) Stedham: Are you in favour of the proposed changes to the speed limit?

Stedham & Iping Speed Limit Reduction

The speed of traffic in Stedham and Iping has been a concern for many residents for some time. A group has now been set-up to complete the work already started by the Parish Council to address this issue.

As part of this work we need your views on any potential speed limit reduction in the village. If a majority is in favour, then the group will prepare separate applications for a Traffic Regulation Order (TRO)* to West Sussex County Council for both Stedham and Iping.

The attached map shows the start and end of the proposed new limits. The details are:

- Stedham

20 Mph zone to apply to The Street, School Lane, Common View, The Alley, Queen Street and Mill Lane (shown in blue)

30 Mph zone to apply to Stedham Lane after Bridgefoot (shown in turquoise)

- Iping

30 Mph to apply to Iping Lane (shown in

turquoise). NB. The

limit here is currently 60 Mph.

The application process is quite lengthy, requiring us to capture speed data and justifying why the changes should be made. The WSCC's review process is even longer and there is **no** guarantee that it will be approved and implemented. Patience will be required!

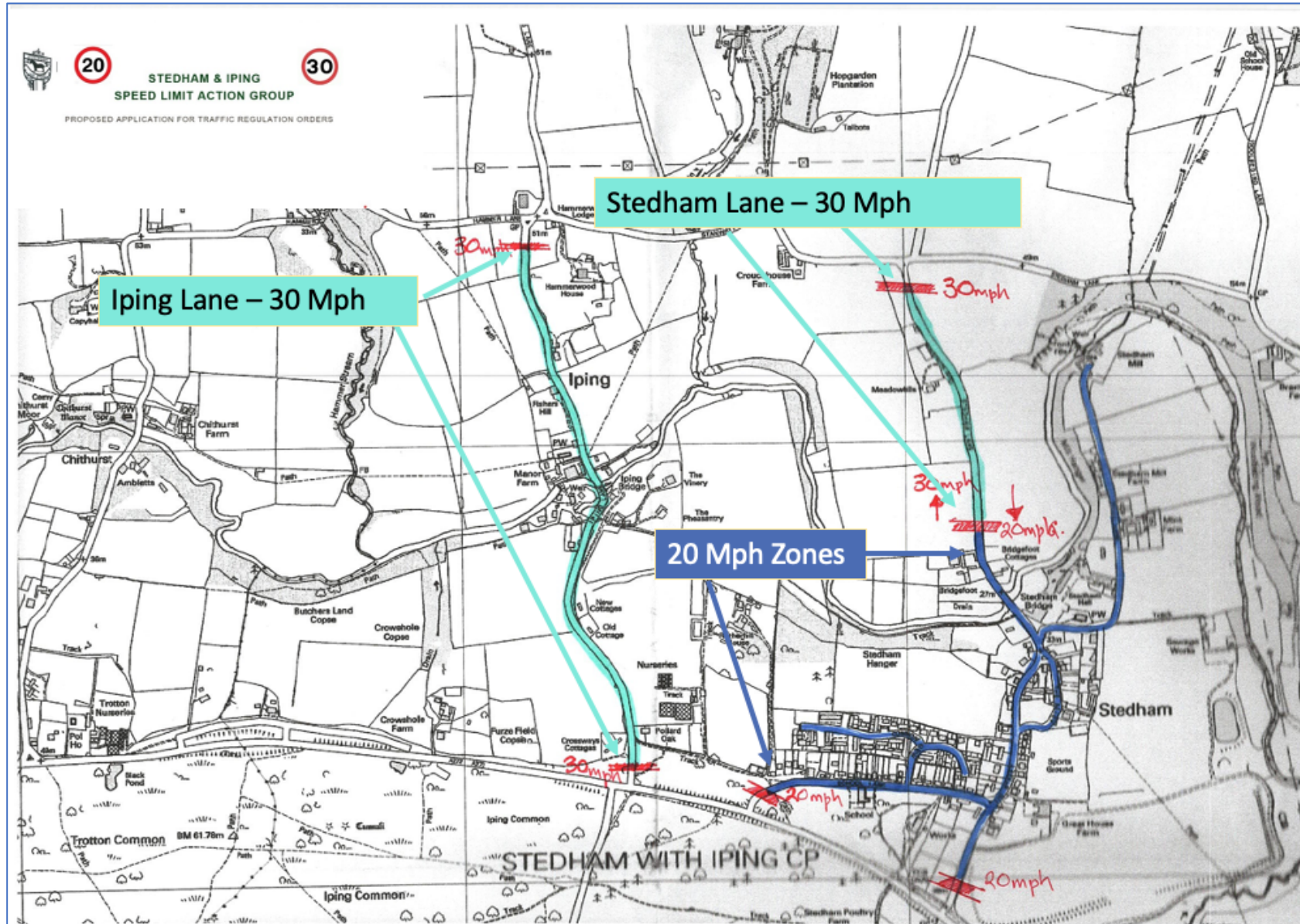
